Safety Minute—Dan Schwartz hat-tip to Doug Cole

It turns out that the old standard procedure for an annual check of a dry powder fire extinguisher - rotating it upside down and whacking it with a rubber mallet to loosen up the powder agent - is exactly what the manufacturers now say not to do. Doing that can force loose powder into the very small nozzle aperture resulting in a blockage (that you'll learn about right when you need to put out a fire.). The newer versions of this type of extinguisher apparently use an agent that prevents caking in the bottom of the cylinder. Professional fire extinguisher service outfits will know the correct way to inspect and certify your fire extinguishers.
